The Texas Commission on Environmental Quality (TCEQ) has assessed our system and determined that our drinking water meets or exceeds all Federal (EPA) Drinking Water Requirements. The analysis was made by using data from the most recent U.S. Environmental Protection Agency (EPA) required tests and is presented in the attached tables. We hope this information helps you become more knowledgeable about what's in your drinking water.

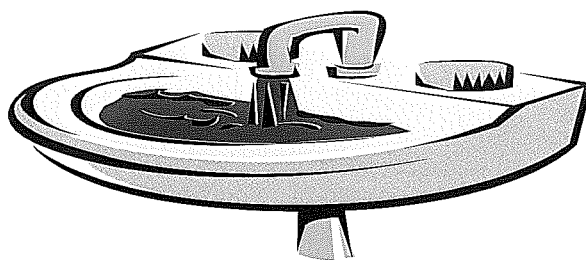


Special Notice for the ELDERLY, INFANTS, CANCER PATIENTS, people with HIV/AIDS or other immune system problems:

You may be more vulnerable than the general population to certain microbial contaminants, such as *Cryptosporidium*, in drinking water. Infants, some elderly or immune-compromised persons, such as those undergoing chemotherapy for cancer; those who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders can be particularly at risk from infections. You should seek advice about drinking water from your physician or health care provider. Where do we get our drinking water?

Our drinking water is obtained from groundwater sources and it comes from the Chicot aquifer. A Source Water Susceptibility Assessment for your drinking water source(s) is currently being updated by the TCEQ and will be provided to us this year. The report will describe the susceptibility and types of constituents that may come into contact with your drinking water source based on human activities and natural conditions. The information contained in the assessment will allow us to focus our source water protection strategies. ALL DRINKING WATER MAY CONTAIN CONTAMINANTS

When drinking water meets federal standards there may not be any health based benefits to purchasing bottled water or point of use devices. The presence of contaminants does not necessarily indicate that water poses a health risk. CONTAMINANTS THAT MAY BE PRESENT IN SOURCE WATER

The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- *Microbial contaminants*, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife;
- *Inorganic contaminants*, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming;
- *Pesticides and herbicides*, which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses.
- *Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff and septic systems; and
- *Radioactive contaminants*, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Federal Food and Drug Administration Agency regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

Secondary Constituents

Contaminants may be found in drinking water that may cause taste, color or odor problems. The taste and odor constituents are called secondary constituents and are regulated by the State of Texas, not the EPA. These types of problems are not necessarily causes for health concerns. Secondary constituents are not required to be reported in this document but they may greatly affect the appearance and taste of your water. Definitions

- AL** Action Level – The concentration of a contaminant, which, if exceeded, triggers treatment or other requirements that a water system must follow.
- MCL** Maximum Contaminant Level – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- MCLG** Maximum Contaminant Level Goal – The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- NA** Not applicable
- NTU** Nephelometric Turbidity Units (a measure of turbidity).
- MRDL** Maximum Residual Disinfectant Level – The highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- MRDLG** Maximum Residual Disinfectant Level Goal – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.
