Everyone must identify themselves once admitted to the meeting.

- 4. Receive Financial Advisor's report, including:
 - a. Review and consider approval of the Official Notice of Sale and Preliminary Official Statement in connection with the District's Series 2025 Bonds and authorize distribution of same;
 - b. Designate a date, time, and place for the sale of the District's Series 2025 Bonds, and authorize the District's Financial Advisor to advertise the sale of same;
 - c. Designate a Paying Agent/Registrar in connection with the District's Series 2025 Bonds; and
 - d. Authorize application to Moody's Investors Service for a credit rating on the District's Series 2025 Bonds.
- 5. Receive Tax Assessor/Collector's report, including:
 - a. Approval of checks drawn on the tax account; payment of invoices presented; and tax refunds.
- 6. Receive Delinquent Tax Attorney's report, including:
 - a. Authorize termination of water service to delinquent taxpayers.
- 7. Receive District Engineer's report, including Projects, Disaster Recovery and Development, and following:
 - a. Permit Amendments and renewals;
 - b. Capacity analysis;
